### Available Vaccination Clinics for Eligible Residents.

The information and links are subject to change:

You must attest that you are eligible to receive vaccine. **By getting the first dose of COVID-19 vaccine you are agreeing that you will abide by your appointment for a second dose.** This appointment will be made at the time of the first dose administration.

Health Systems can vaccinate anyone who qualifies for the vaccine and primary care providers will contact their eligible patients randomly as vaccine becomes available. Take your Medicare and/or insurance card with you for possible administrative fees, however there will be no charge to you for the vaccine. You must also have proof of your age.

**PHARMACY Providers:** Please note the pharmacies can now vaccinate anyone who qualifies for the vaccine. Just because the pharmacies are listed doesn't mean they currently have vaccine. Use their online links to register. Please do not call the pharmacy requesting COVID vaccine as their staffing is limited. Appointments are encouraged. Many locations may provide walk-in clinics. Take your Medicare and/or insurance card with you for possible administrative fees, however there will be no charge to you for the vaccine. You must also have proof of your age.
