What is the Incident Command System?

The Incident Command System (ICS) is a standardized approach that:

- Is part of the broader National Incident Management System (NIMS)
- · Is applicable to all types of incidents, regardless of size, cause, or complexity
- Can be used either for emergencies or planned events
- Enables a coordinated response among various jurisdictions and agencies
- Establishes common processes for incident-level planning and resource management
- Allows for integration of resources (such as facilities, equipment, personnel) in a common structure
- Applies to everyone in an emergency response (including volunteers)

Why is ICS important to know about?

Having a better understanding of the ICS structure and process helps different agencies work together in unprecedented ways at times of emergency

- · Fosters new cooperation and collaboration
- Clarifies the chain of command and supervision responsibilities
- Improves accountability
- Provides an orderly, systematic planning process with standardized concepts and terminology
- Implements a common, flexible, predesigned management structure
- Helps diverse agencies and people who may be unaccustomed to working together in high pressure environments to engage in safe and effective response



ICS Structure



ICS Positions and Sections:

Incident Commander: Has overall responsibility for the incident, sets priorities, and determines incident objectives and strategies. Also determines the ICS organization needed to manage the incident.

Public Information Officer: Communicates information to the public.

Safety Officer: Ensures safety of community members, volunteers, and responders.

Liaison Officer: Acts as the point of contact for agency representatives, maintains a list of assisting and cooperating agencies and representatives, and assists in setting up and coordinating interagency contacts.

Operations Section Chief: Develops tactical organization and directs resources for incident response.

Planning Section Chief: Develops Incident Action Plan to accomplish the objectives.

Logistics Section Chief: Provides resources and services needed to support the incident.

Finance/Admin Section Chief: Monitors incident-related costs and provides overall fiscal guidance.
